## Introduction:

## 1. The ACLU of Hawai'i sits on land that has been stewarded for generations by Native Hawaiians.

- a. "Native Hawaiians are a distinct, Indigenous people whose ancestors were the original inhabitants of what is now considered the State of Hawai'i."1
- b. While we work within the federal and state legislature and courts to protect civil liberties and demand greater freedom for all Hawaii's residents...
- c. We also acknowledge that "Native Hawaiians have never relinquished their sovereignty or settled their claims with the United States."2
- d. The ACLU of Hawai'i supports and honors the unique rights and voices of Native Hawaiians.

## 2. Freedom is often marked by civil liberties that people do and do not have.

- a. An interesting layer to the dynamic of civil liberties is that to have a free society, we must also have a safe society.
- b. Today, with complicity of the Federal Bureau of Investigation, we are seeing federal law enforcement agencies conduct raids where "people work, shop, eat, and live."<sup>3</sup>

- c. We have seen numerous unlawful detentions based solely on a "person's perceived race, ethnicity, or national origin" in violation of the  $4^{th}$ ,  $5^{th}$ , and  $14^{th}$  Amendments.<sup>5</sup>
- d. Our communities will never be safe so long as federal agents continue to terrorize them<sup>6</sup> and rip families apart.<sup>7</sup> They will never be safe while federal agents "us[e] excessive force, [smash] car windows, and pull people from their cars."<sup>8</sup>
- e. So as long as our communities feel unsafe from racially-motivated attacks by law enforcement, they will remain unfree.<sup>9</sup>
- f. That is why ACLU of Hawai'i is hosting this panel today to protect your freedom, dignity, and humanity by empowering you to Know Your Rights.
- 3. **Modern FBI**: The FBI's stated mission is to "protect the American people and uphold the Constitution of the United States." <sup>10</sup>
  - a. The FBI's foundation rests on three principles: (1) fidelity, (2) bravery, and (3) integrity.<sup>11</sup>

- b. Today, the FBI's website lists (1) crushing violent crime, (2) defending the homeland, (3) rebuilding public trust, and (4) fierce organizational accountability as its priorities.<sup>12</sup>
- 4. The Federal Bureau of Investigation ("FBI") was founded on July 26, 1908, when Attorney General Charles J. Bonaparte "appointed an unnamed force of special agents to be the investigative force of the Department of Justice." <sup>13</sup> The FBI as we know it today evolved from this small group of special agents. <sup>14</sup>
  - a. Initially, investigations focused mainly on white-collar, civil rights cases, <sup>15</sup> and national security issues. <sup>16</sup>
  - b. However, during WWI, Congress passed the Espionage Act and the Sabotage Act, which placed the FBI in the "counter-spy business." <sup>17</sup>
  - c. The FBI was also tasked with "rounding up army deserters and policing millions of 'enemy aliens' Germans in the U.S. who were not American citizens as well as of enforcing a variety of other war-related crimes." <sup>18</sup>
  - d. During rare moments of anti-racist nobility in the Civil Rights Movement, the FBI was tasked with "battling" the KKK<sup>19</sup> and handled cases involving police brutality or other civil rights crimes by state and local authorities.<sup>20</sup>
  - e. Simultaneously, the FBI's involvement in national security investigations was increasing. The FBI "took the lead in investigating the high-profile assassinations of national leaders like President Kennedy, Martin Luther

King, and Senator Robert Kennedy. It also investigated the Kent State shootings and other related incidents and attacks." <sup>21</sup>

- 5. **Local Impact:** Prior to WWII, the FBI had already identified "German, Italian, and Japanese aliens who were suspected of being potential 'enemy agents,' keeping them under surveillance." <sup>22</sup>
  - a. As racist suspicions against Japanese Americans grew, the FBI began monitoring plantation labor organizers in Hawai'i and by 1932, "the entire Japanese American community was under active surveillance." <sup>23</sup>
  - b. Immediately after the attack on Pearl Harbor, however, the FBI began conducting raids against Japanese immigrants living in Hawaiʻi.<sup>24</sup>
  - c. Japanese immigrants were arrested and detained for weeks at a time, before later being transferred to internment camps.<sup>25</sup>
  - d. Japanese Americans in Hawaiʻi were subjected to monitoring by multiple investigative agencies, including the FBI.<sup>26</sup>
  - e. Ultimately, however, after over a decade of investigations and surveillance, "no fifth column…no double agents, no terror cells or subversive plots" were ever found.<sup>27</sup>
- 6. While the FBI's history undoubtedly includes many civil rights victories, the FBI's history has also been troublesome, resulting in harms committed against the American people.
  - a. During the period following WWII, the FBI played a key role in the "rapid, major deterioration in the civil liberties climate" through its "deliberate attempts to ignite a domestic Red Scare."<sup>28</sup>

- i. Under the leadership of J. Edgar Hoover, the FBI established programs which utilized wiretaps and surveillance to uncover American communists, <sup>29</sup> which ultimately led to the executions of Julius and Ethel Rosenberg, "the first American civilians to be executed for conspiracy to commit espionage and the first to suffer that penalty during peacetime." <sup>30</sup>
- ii. Out of fear that he would align himself with the Communist Party, the FBI also engaged in an "intense campaign to discredit Martin Luther King Jr." through the use of wiretaps and blackmail.<sup>31</sup>
- b. Since 2001, the FBI has experienced a striking expansion of power.<sup>32</sup>
  - i. This expansion of power was largely influenced by the attacks on 9/11 as suspicions against minorities, particularly Muslim Americans, grew.<sup>33</sup>
  - ii. Just 11 months after the attacks, 762 noncitizens (a majority of which were from Muslim majority countries<sup>34</sup>), many of whom were arrested indiscriminately and haphazardly,<sup>35</sup> had been detained in connection with the terrorism investigations conducted by the FBI.<sup>36</sup>
  - iii. Additionally, the FBI worked closely with the Department of Homeland Security to create and implement programs that would prevent the information-sharing failures that led to Sept. 11."<sup>37</sup>
- c. With this large expansion of power, the FBI has:

- i. Gathered information about millions of law-abiding Americans.<sup>38</sup>
- ii. Tracked communications and associations.<sup>39</sup>
- iii. Mapped American communities based on race, ethnicity, religion, and national origin.<sup>40</sup>
- iv. Exploited community outreach programs to monitor the First
   Amendment activities of religious groups.<sup>41</sup>
- v. Harassed non-violent political activists with surveillance, unwarranted investigations, and aggressive nationwide raids that resulted in no criminal charges.<sup>42</sup>
- d. In 2013, the ACLU published "Unleashed and Unaccountable: The FBI's Unchecked Abuse of Authority," which not only documented this expansion of power, but also "establishe[d] a foundation for reform with recommendations to ensure FBI respect for civil liberties." <sup>43</sup>

## 7. Today, we are continuing to see these harms inflicted on our communities.

- a. Over the last 6 months, I have received multiple calls from community members who have been visited by the FBI, mainly in their home.
- b. FBI visits are leading to community panic, fear, and silencing.
- c. **Free Speech**: Some local residents have been approached to discuss their opinions on Palestine or work with professors who have engaged in topics that have intersected with Palestine.

- d. **National Identity**: Other local residents have been asked about their financial interests and lawful remittances paid to family in Iran. While others have had their accounts frozen pending investigation.
- e. **Religious Identity**: Furthermore, while religious practices have not specifically been questioned or targeted, the majority of folks being questioned or investigated are Muslim.
  - i. This results in Muslims feeling just as unsafe and as targeted as they did in a post-9/11 era.
- f. **Immigrant Rights Committee**: Our community partners on the ground have shared with us that they have seen greater involvement of the FBI in immigration enforcement activities.<sup>44</sup>
  - i. FBI agents have assisted ICE operations by securing perimeters for ICE raids. 45Other federal agencies are also helping "reluctantly." 46
- 8. For these reasons, it is difficult for our communities to see the FBI as a trusted partner in today's political climate.
  - a. Accordingly, we are hosting this event to empower you with knowledge.
  - b. Knowledge of your rights and how to exercise them is imperative to ensuring that your civil liberties and civil rights as individuals, and also as a community, remain intact.
  - c. We also hope that this knowledge will mitigate the fear that flows from increased interactions with the FBI.
  - d. Today's panelists will be speaking on (a) your constitutional rights when dealing with the FBI; (b) what to know about FBI investigations and target letters; (c) how to respond if the FBI wants to search you or your home; (d) what to do if the FBI comes to question you; (e) how the community can safely respond when a person has been arrested and/or detained by the FBI.<sup>47</sup>
