Hi everyone,

I know many of you have your heads down and your fingers working on your NOFA applications. Sorry to interrupt you.

Sometime on Wednesday, you should have received a memo from me (via June) that detailed the possibility that additional funds and a contract extension for Housing Placement Program might be a possible result of an Emergency Proclamation by Governor Ige. It seems as though the EP might be issued, so I wanted to give you all an up-date on the funding.

You all received a 6 month contract (7/1/15-12/31/15) worth half of the amount you normally receive for an annual contract. The table below shows the additional funds you would receive for the 2nd 6 months of the contract (B) and the supplemental amount based on a pro-rata division of the additional funds being offered (\$500,000). Column D shows you what your total contract would be worth.
