## COMMUNITY PARTNERS TO HOST HAWAI'I JUSTICE GUBERNATORIAL FORUM

HONOLULU: 'Ekolu Mea Nui and ACLU of Hawai'i, along with community partners, will host a **justice-focused gubernatorial candidate forum** on Sunday, July 17th on O'ahu. The event will provide voters with critical information, prior to the Saturday, August 13th Primary Election, on where the candidates and their parties stand on criminal justice issues in Hawai'i.

Public health crises like poverty, mental illness, substance use disorders, and houselessness are more appropriately addressed through criminal justice policies and approaches focused on achieving safety and stability for all our communities, including violence interrupters, drug treatment, reentry support, living wages, and affordable housing. We believe the future Governor of Hawai'i should use their executive powers in new and transformational ways that confront racial and economic injustice, readdress the harm of the criminal legal system, and invest in effective community-based solutions to ending mass incarceration. **NOTE: The ACLU of Hawai'i does not endorse or oppose candidates for elected office.**
